

PORT SECURITY –

Fredriksskans and Granuddens Port Facilities

Information regarding port security within Fredriksskans and Granudden Port Facilities

This information has been issued because of the international rules concerning port security (the ISPS Code) in operation from July 1st 2004 and aims at clarifying the rules that apply within the port facilities.

Prenotification

24 hours prior to their call at the latest, visiting vessels should prenotify the port inwriting of their arrival. The vessel should notify the port of its security level for the call, as well as of what level applied in the ports previously visited. The vessel should also report its IMO number.

Current lists of crew and any passengers for the call should be kept available for the port authorities, in case they demand to see them.

Change of crewmembers, expected visits, need of provisions, need of repairs/spare parts should be reported to the security organisation of the port.

ISPS areas

The ISPS areas are signposted and marked.

People within these areas can be asked to show their identification papers.

Crew members identification papers

Crew members staying within the ISPS areas should be able to present an IMO-ID or valid seaman's passport. Through the care of the master of the vessel, passengers should be equipped with identification papers. Failing to present valid identification papers, passengers will be turned away and reported to the police.

Costs for temporary identification papers will be charged to the vessel.

Port Security Declaration/DOS

The ship agent or VTS/Bönan can inform vessels about the current security level of the port.

Vessels with a higher security level than that of the port or regarding themselves in need of increased security should report this to the port authorities.

Reports: Weekdays 08:00 - 16:00, at least 48 hours before arrival.

Costs incurred in connection with such a demand will be charged to the vessel.



Vessels not in compliance with the ISPS Code

Vessels not in compliance with the ISPS Code, or arriving from a port of call that does not fulfil the demands, will be charged all extra port security costs related to its call.

Port Facility Security Organization

The Port of Gävle is responsible for the ISPS organization of the Energy Port/Terminals (quay no 1 and 27). The port terminal operator Yilport Gävle is responsible for the ISPS organization of the Container, Bulk and Granudden Terminals.

For the Energy Port/Terminals, a Port Facility Security Officer (PFSO) can be reached 24 hours a day, 7 days a week, by contacting the Port Traffic Office at phone number +46 26 178866.
